The Board of directors in their meeting held on 14th November, 2024 has proposed to increase the remuneration of Mr. Vishal Sharma from INR 2.50 Lacs to INR 4.00 Lacs per month w.e.f. 01st November, 2024 for a remaining period of term on the basis of recommendations of Nomination and Remuneration Committee of the Company, subject to approval of shareholders.

As per Section 196, 197, 198 and 203 of the Companies Act, 2013 any increase of remuneration of Whole Time Director, Managing Director and KMP shall be approved by Board of Directors and subsequently by the shareholders of the Company.

Since members' approval for payment of remuneration to Mr. Vishal Sharma for the aforesaid remaining term of his appointment is being sought by way of special resolution, the limits prescribed under Schedule V of the Act shall not be applicable to the Company in case there is a loss/ inadequacy of profits during his term of appointment.

The Board recommends the Resolution as set out at Item no. 1 of the Notice for approval of the Members as a Special Resolution.
